#### 4. FIRST AID MEASURES

#### 5. FIRE-FIGHTING MEASURES

**Flash Point:** > 110°C (> 230°F)

**Fire and Explosion Hazards:** Thermal decomposition may produce toxic fumes (see Section 10).

**Extinguishing Medium:** Water fog, foam, dry chemical or carbon dioxide (CO<sub>2</sub>).

**Fire Fighting Equipment:** Firefighters should be equipped with self-contained positive pressure breathing apparatus and full bunker gear.

**Fire Fighting Instructions:** Evacuate area of all unnecessary personnel and fight fire from a safe distance upwind. Contain contaminated water / firefighting water; do not allow to enter drains or waterways. #### 6. ACCIDENTAL RELEASE MEASURES

**Personal Precautions:** Isolate area and keep unnecessary and unprotected personnel from entering. Wear suitable personal protective clothing and equipment as described in Section 8 of this document.

**Environmental Precautions:** Prevent material from entering public sewer systems or any waterways. Do not flush to drain. Large spills to soil or similar surfaces may necessitate removal of topsoil. The affected area should be removed and placed in an appropriate container for disposal.

**Spill Cleanup:** Dike spill using suitable absorbent or impervious materials such as earth, sand, or clay.
